 HEALTH HAZARD DATA

ACUTE HEALTH EFFECTS:

INHALATION: Not a likely route of exposure.
 SKIN CONTACT: Repeated or prolonged exposure may dermatitis.
 EYE CONTACT: May cause irritation.
 INGESTION: May cause oral or gastrointestinal irritation, vomiting, and diarrhea.

CHRONIC HEALTH EFFECTS:

Due to the nature and composition of this product, no subchronic/chronic health effects are anticipated. Nonetheless, the following effects have been reported for one of the product's components: This product may contain greater than 0.1% DEA. The National Toxicology Program has concluded that there is clear evidence of liver tumor and some evidence of kidney tumor in mice dermally exposed for their lifetime to diethanolamine. The significance of these findings and their relevance to humans is not clear. Diethanolamine is not genotoxic (neither mutagenic or clastogenic) and did not induce tumors in rats or in transgenic mice similarly treated. Additional research to better understand these findings and their relevance to humans, if any, is underway. Normal use of this product is not expected to produce these effects.

MEDICAL CONDITIONS GENERALLY RECOGNIZED AS BEING AGGRAVATED BY EXPOSURE: None known.

 EMERGENCY AND FIRST AID PROCEDURES

INHALATION: Remove from exposure area to fresh air immediately. Keep affected person warm and at rest. Treat symptomatically and supportively. Contact physician or local poison control center. If breathing has stopped, give artificial respiration, and get medical attention immediately.

SKIN CONTACT: Rinse affected area with large amounts of water until no evidence of product remains. Get medical attention if irritation persists.

EYE CONTACT: Immediately rinse eyes with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation persist.

INGESTION: Treat symptomatically and supportively. Maintain airway and respiration. If vomiting occurs, keep head below hips to prevent aspiration. Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. If unconscious, the victim should not be given anything to drink.
