### EFFECTS OF ACUTE EXPOSURE

**EYES:** May cause eye irritation. Symptoms may include redness and pain.

**SKIN:** May cause mild skin irritation. Symptoms may include redness.

**INHALATION:** High concentrations of vapor or mist may cause nose, throat and respiratory tract irritation. Symptoms may include coughing.

**INGESTION:** May cause mouth, throat and stomach irritation. Symptoms may include nausea, vomiting and diarrhea. May also cause central nervous system effects including headache, dizziness and weakness.

#### 4. FIRST AID MEASURES

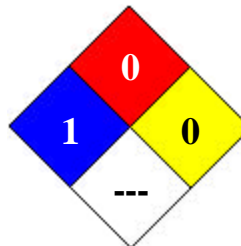
