EYES: May cause eye irritation. Symptoms may include redness and pain.

SKIN: May cause mild skin irritation. Symptoms may include redness.

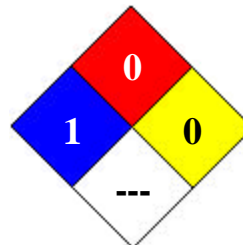
