Incompatibility (Materials to Avoid): Oxidizing agents, heat and open flame.

Hazardous Decomposition Products: Carbon monoxide, carbon dioxide, hydrogen chloride, phosgene and additional toxic chemicals may be formed in small amounts.

Conditions to Avoid: Do not store above 54C-130F. Keep away from heat, direct sunlight, open flames or sparks.

Dropping of containers may cause bursting.

SECTION VI - HEALTH HAZARD DATA

Signs and Symptoms of Exposure: Inhalation is the primary route of exposure and may cause dizziness, drowsiness and throat irritation. Prolonged or repeated skin contact can cause irritation and defatting of skin. Chronic exposure to methylene chloride and perchloroethylene has caused liver toxic effects in experimental animals.

Medical Conditions Generally Aggravated by Exposure: Preexisting skin or eye disorders may be aggravated by exposure to this product. Acute and chronic liver disease and rhythm disorders of the heart.

Emergency and First Aid Procedures: Eye Contact: Flush eyes with plenty of water for 15 minutes while holding eyelids open. Get medical attention if irritation persists. Skin Contact: Remove contaminated clothing. Flush skin with water; follow by washing with soap and water. If irritation occurs, get medical attention. Do not reuse clothing until cleaned. Inhalation: Remove victim to fresh air and provide oxygen if breathing is difficult. Give artificial respiration if not breathing. Get medical attention. Ingestion: Get medical attention. NOTE TO PHYSICIAN: Adrenaline should never be given to persons overexposed to perchloroethylene.

SECTION VII - PRECAUTIONS FOR SAFE HANDLING AND USE

Releases or Spilled: Remove all sources of ignition and ventilate area. Soak up spill with an inert absorbent and place into a designated disposal container. Consult local regulatory agency for proper disposition of material.

Waste Disposal Method: Do not puncture or incinerate containers. When contents are depleted continue to depress button until all gas is expelled. Dispose of container in accordance with local, state, and federal regulations.

Handling And Storing: Avoid breathing vapor. Keep away from heat and flame. Use with adequate ventilation. Do not puncture or incinerate containers. Do not expose to direct sunlight or store at temperatures above 130F (54C). Store as Level 1 Aerosol (NFPA 30B).

Other Precautions: Please read and follow the directions on the product label; they are your best guide to using this product in the most effective way, and give the necessary safety precautions to protect your health.

SECTION VIII - EMPLOYEE PROTECTION
